- 1. PAYMENT: Unless otherwise agrees to in writing by McNeece Bros., the undersigned CUSTOMER agrees to the following terms in all credit transactions. McNeece Bros. credit terms, if approved, are net 10th, meaning that all bills are due by the 10th, day of the month following the purchase. We require that our customers pay according to these terms. No order will be approved for delivery to a customer with a balance past due.
 - Special terms: Net calendar _____days from date of the fuel delivery.
 - All other purchases from the first through the fifteenth calendar day of each month are due and payable no later than the
 last calendar day of the same month.
 - All other purchases from the sixteenth through the last calendar day of each month are due and payable no later than fifteenth calendar day of the month following purchase.

In the event said charges are not so paid, CUSTOMER agrees to pay **McNeece Bros**. a service charge of 1.5% per month on unpaid balance and agrees to forfeit any and all volume discounts. Further, **McNeece Bros**. can refuse further charges to CUSTOMER. This service charge is not an alternative performance provision.

- 2. TAXES. CUSTOMER agrees to pay any and all applicable sales, excise and use taxes. CUSTOMER agrees to provide McNeece Bros. with any and all certificates that may allow CUSTOMER to be exempt from certain State and / or Federal sales, excise or use taxes.
- 3. RECEIPT OF DELIVERIES. CUSTOMER authorizes McNeece Bros. to make requested and /or schedule deliveries of its products whether or not CUSTOMER or his/her representatives are present to sign the delivery invoice. CUSTOMER agrees to pay for all such delivered products under the terms and conditions set forth.
